PUBLIC COMMENTS

Tom Schulz inquired if there was to be an official DPW Garage opening? Mayor Dumas noted that there would be an official opening in the Spring.

Tom Schulz also noted that at his property at 259 West Main Street the sewer line backs up on average of two times each year. At first there were tree roots that had clogged the line so he had the pipes replaced about twenty years ago. However, the backups keep occurring. Is there a map that shows where the main comes from and goes to?

Mayor Dumas advised Tom to have a backflow preventer installed to ensure no backups get into his property. Also, the Village DPW will come to the location and camera the line to see if it could be that the couplings on the pipe have settled and broken the clamps.

Tom Schulz also restated the ongoing issue with the sidewalk in front of his Main Street business and the ongoing battle with the NYS plows. The constant plowing under of the sidewalk does not make Malone a pedestrian friendly Village.

Both Mayor Dumas and Trustee Bonner have spoken directly with the NYS DOT about resolving this issue. The Board will draft a certified letter requesting a foil be added to the wing of the State plow when driving Main Street.
