AUTHORIZATION FOR MAYOR TO SIGN FRANCHISE AGREEMENT WITH SPECTRUM NORTHEAST, LLC, AN INDIRECT SUBSIDIARY OF CHARTER COMMUNICATIONS

Reason: In the Matter of the Granting of a Cable Television Franchise Held by **Spectrum Northeast, LLC** in the **Village of Malone, County of Franklin**, New York

An application has been duly made to the Board of the Village of Malone, County of Franklin, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of a renewal agreement for Charter's cable television franchise for seven (7) years commencing with the date of approval by the Public Service Commission.

The franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Village of Malone, New York on November 13, 2023 at 5:00 P.M. and notice of the hearing was published in the Malone Telegram on October 27, 2023.

NOW, THEREFORE, the Board of the Village of Malone Board of Trustees finds

that:

- 1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Spectrum Northeast, LLC can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the **Village of Malone Board of Trustees** hereby grants the cable television franchise of Spectrum Northeast, LLC and the **Village of Malone** for seven (7) years commencing with the date of approval by the Public Service Commission and expiring seven (7) years hence.

BE IT FURTHER RESOLVED that the Board of the **Village of Malone** hereby confirms acceptance of this franchise renewal agreement.

ADOPTION OF LANGUAGE ENGLISH PROFICIENY (LEP) PLAN

PURPOSE: In compliance with Title VI of the Civil Rights Act of 1964 and Executive Order 13166, "Improving Access to Services for Persons with Limited English Proficiency", the Village of Malone has established the attached Language English Proficiency Plan (LEP) to ensure that individuals with limited English proficiency (LEP) may access all resources and services provided by the Village of Malone. An "LEP Individual" is defined as "an individual who does not speak English as their primary language and who has a limited ability to read, speak, write, or understand English."

WHEREAS, the Village of Malone has had no previous Language English Proficiency (LEP) Plan; and

WHEREAS, the Village developed such a plan; and

WHEREAS, the contents of this Plan moving forward should be reviewed each year;

PUBLIC COMMENTS

Jason Smart inquired as to where the Old Lashomb property was located. Mayor Dumas noted the address is 411-415 E Main and is currently referred to as "the property at 411-415 E Main".

Tom Schulz inquired as to why the remaining Main St Grant funds cannot be used to do more work in Mill Park. Mayor Dumas noted that since it was a Main Street grant there are limited projects the money can be spent on. The property must be located on the designated section of Main Street and meet the criteria established by the grant's project outcomes.

Tom also asked if there was a plan in place to ensure that whoever develops the land where the Flanagan sits, to ensure the developer abides by certain restrictions, such as no box stores or convenience stores.

Mayor Dumas noted safeguards will be set in place prior to the sale of the property, post demolition.

Dr. Martin asked what the anticipated opening date was for Harison Place. Mayor Dumas noted that the tentative opening should be in February 2024. All the units have been leased, as well as the commercial spaces on the first floor.

Dr. Martin inquired if there were any safeguards being implemented to ensure acceptable tenant behavior. Mayor Dumas noted that Citizen Advocates is working diligently to ensure a smooth opening and successful operation of the building and its tenants. The hope is that with Background checks, occupancy criteria and the regulations of the building that this will prove a positive housing option within the Village of Malone, and a model for other communities considering similar options.

Tom Schulz asked if Citizen Advocates will have their own officer to monitor the building. Mayor Dumas noted that is not currently in the final plan for the building.

Dr. Martin offered sincere congratulations to Trustee McKee, Trustee Langdon, and Mayor Dumas on their successful reelection to the Village Board.
