### **Wastewater Treatment Plant**

- Barton & Loguidice – Preliminary Engineering Report for Pre-Leachate Study

Taylor Bottar discussed with the Village Board the general findings for the Preliminary Engineering Study Report for the Pre-Leachate. The NYS DEC has sent down some additional regulations and those changes will affect the type of treatment selected. The PFAS treatment regulations are changing and addressing these new regulations now will be more cost effective.

Grant and funding opportunities will be sought to assist in offsetting the cost of implementing the treatment measures necessary as outlined by the report. B&L will seek an extension from the DEC on the Leachate system until a final solution is made.


