NEW BUSINESS

> Empire Baseball League

Gregory Paye addressed the Board of Trustees concerning the American Legion Baseball League and the field currently maintained near the Airport in the Town. Over twenty years ago the Veteran's Field was built. The American Legion is proposing and looking for support to bring the Empire Baseball league to Malone and upgrade the current field to suit the team's needs.

Present with Mr. Paye was Eddie Gonzales, Taylor Nichols, and John Lantigua from the Empire Baseball League. They discussed the nature of the league, their purpose and the 2.5 months of baseball they would be playing here in Malone. Currently, Empire BL has teams in Saranac Lake and Tupper Lake. The teams bring in big business for the areas in which they play, while supporting the "Underdog" players that have been overlooked by the Major League, ages 21-26. Players come from all over the United States and Puerto Rico. The League has been in existence for six years and their platform is often used as a scouting venue for the Minor League.

The American Legion is establishing a Veteran's Field Committee to raise the \$70,000 needed to upgrade the field. They are looking to include a representative from both the Town and Village Boards, and two additional members at large. Currently the field is flat, making it a good place to start. There needs to be improvements to the grass and surface to reach a standard of play necessary for this caliber of players. There also needs to be fencing and netting installed to meet the safety requirements for the new stands where visitors will sit.

The league recruits from more than 3,000 players each year, released from the Major League that are not signed. The current playing season is June thru August, with 65 scheduled games.

Mayor Dumas noted that the Board would bring the League up at the next Village work session and there assign a representative from the Village to the new committee.
