## **PUBLIC COMMENTS**

Mr. Paquin asked about the increase in migrant activity the Village of Malone has been seeing. Could the Village Mayor or Chief of Police assist in helping him understand the situation and what the future is going to look like.

Chief Andre noted that when migrants are picked up crossing the Border, an agent assigned has to process the individual for any crimes that have been committed within the US and Interpol. If there are no records, the individual is equipped with an ankle monitor and must be released near access to shelter and food. The ankle bracelet is to monitor where they go until they are to report to court for the crime of entering the Country illegally.

This is due to laws passed sown from the Federal level. The County Legislature nor the Village Board has any say in this process. Usually those dropped off in Malone will not stay in the area more than 36 hours. They near immediately seek transportation to the bigger cities.

Chief Andre noted this current process and situation is unlikely to change as long as the current Federal administration remains the same. There have been no reported incidents of crimes being committed in the Village of Malone by any of the migrants that have been released so far.

Mr. Paquin noted his appreciation for the information and the job the Malone PD has been doing.

Dr. Martin asked if the Village was losing its Code Officer and if the Village was paying a decent salary for the position. Mayor Dumas noted the salary is competitive and that the Village is actively looking for a replacement Code Officer.

Tom Shultz asked if the Board could ensure that the New York State Department of Transportation officials will all be available when they decide to hold a public stakeholder's meeting on the Main Street Pedestrian Islands and traffic.

Tom also inquired if there was security at the new Citizen Advocates housing on Main Street. Mayor Dumas noted that there is not 24-hour security.

Trustee Langdon asked if the Board would consider a monthly special recognition of a community member who goes above and beyond to serve the community.
