At a Work Session of the Malone Village Board, held on November 18, 2020 at 9:00 AM at 343 West Main Street the following were present:

Mayor Dumas called the work session to order at 9:00 AM.

#### **Centrica Business Solutions**

> Presentation of Preliminary Assessment for Village of Malone Street Lighting

Centrica Business Solutions' representatives presented their preliminary findings beginning with a background on National Grid's street lighting and billing structure used to calculate Village bills. They noted that the structure of the proposed project would enable the project to fund itself through the energy and maintenance savings the Village would realize, essentially creating a "no out-of-pocket" cost to the Village of Malone. Further, the proposed project would have no affect on the current tax base or debt limit. The projected annual savings would be guaranteed by Centrica Business Solutions.

The presentation calls for the Village to purchase back from National Grid all of the current Cobra-Head fixtures and one flood light fixture. The poles remain in the possession and control of National Grid. Centrica Business Solutions would then have new LED fixtures, photocells, and in-line disconnects installed and a GIS mapping of all streetlights would be provided. Furthermore, the proposal includes new LED fixtures in the existing Village owned streetlights on Main Street.

Benefits of the proposal include a significant reduction in system maintenance and energy use costs, a 10 year material warranty and a useful life of 25-30 years, with a projected investment of \$500,963 on a twelve year term with upwards of \$800,000 revenue at the twenty year mark and an annual savings of \$67,478.

The Village of Malone would take over maintenance of the light fixtures. Any work done would have to be completed by a lineman-electrician. The Village of Malone would have to sign a letter stating that no unqualified individuals would be working on the lights.
