**NY Main Street Technical Assistance Grant** – Awarded \$21,000 in December 2019; Written with two distinct outcomes:

- 1. Develop architectural design guidelines for downtown Malone buildings to ensure historical architecture preserved during re.
- 2. Building a Façade Study by an approved architectural firm to render design drawings and itemize improvements that can be made to downtown buildings ensuring historical accuracy.

In-Site Architectural Firm was hired to work on these two outcomes with the following goals in mind:

To provide valuable information necessary in assisting property owners when seeking future NY Main street grant funds to do renovations.

Phil reported on the outreach currently underway to solicit application from Main Street property Owners, interested in being selected to receive one of the Building Façade Studies. More than 52 Letters have been sent. Currently six property owners have submitted applications. Phil has asked the Board for assistance in generating an additional 4 applications that would be a great fit for this grant. The current grant provided for five studies to be done. With a nominal fee (\$100-150 each) by selected applicants it may be possible to have seven studies done.

Village Board Members will reach out to those property owners who have yet to apply, encouraging them to get their applications in.

Jeremy will reach out to In-Site to determine the cost of each study to assist in generating a final figure on the proposed, nominal fee.

In-Site will be coming to Malone in July to do a walk-through. They are hoping to meet with some of the applicants about the buildings and possibly hold a public design workshop.
