WHEREAS, The Village of Malone Water Pollution Control Facility's Outfall 002 consists of 16.5-acres of rapid infiltration beds, primarily used in the 1970s, as a secondary treatment process; and

WHEREAS, in the 1980s these were replaced with a series of Rotating Biological Contractors (RBCs), making the infiltration beds a secondary source utilized only during high flow events and the occasional plant maintenance; and

WHEREAS, the disadvantages, including maintenance labor requirements, limited access to OF 002, additional laboratory costs and imminent engineering evaluation costs, far outweigh the advantages of continuing to utilize the OF 002 as a permitted outfall;

NOW, THEREFORE BE IT RESOLVED: The Board of Trustees has authorized DANC to submit a memo to the DEC informing them of the decision to decommission the Village of Malone Water Pollution Control Facility's Outfall 002.

Liberty Utilities Discussion

Joined Meeting at 10:00AM

Dr. Calvin Martin, Clay/Milwaukee Neighborhood Association Mr. Ryne Martin, Liberty Utilities – Manager of Government Affairs Ms. Kim Baxter, Liberty Utilities – Manager of Regulatory Affairs Mr. Ryan Hayes, Liberty Utilities – Manager of Special Projects

Discussion was held on the forward motion of Liberty Utilities' project and the concerns of Village residents.

Dr. Martin, representing the Clay/Milwaukee Neighborhood Association, who are not against Liberty Utilities bringing natural gas to Malone, but do have a few concerns. Is Liberty Utilities aware that the Town of Malone and the Village of Malone are separate entities?

Ryne Martin expressed that Liberty Utilities is clear that the Town and the Village are separate entities. Cases #10-G-0154 (2010) and #10-G-0295 (2012) reflect original CPN and the Amendment for the Village of Malone.

Dr. Martin feels these need updating because the company is no longer St. Lawrence Gas.

Liberty Utilities noted that even though the company name has changed, they are the same people running the company and the PSC recognizes this.

Dr. Martin is requesting that Liberty Utilities come to the table with the Village of Malone and the Homeowners Association and discuss the intended pipeline route, street by street and the possible affects on trees, and sewer and water lines. He believes that Liberty jumped the gun and came down Clay without proper permits and authority. Clay street is one of the few treelined streets left in the Village of Malone. This street also has ceramic water and sewer lines that are fragile.

Liberty Utilities assured the Board that they have no plans to remove any trees and are aware of the water and sewer lines fragility and locations and will work with the Village to protect them.

The Clay/Milwaukee Neighborhood Association has a recording stating that a major root of a mature red maple was affected by the installation of the gas lines to the medical office. The association does not want Liberty Utilities to have an overarching right of way as often provided through the CPN from the PSC and urges the Village to negotiate a veto power over the routes the gas line can take.

Kim Baxter with Liberty stated that they have filed with the PSC for 2021 and that application is being reviewed at this time.

Mayor Dumas thanked all who were present for the discussion and asked Liberty Utility to forward the 2010 and 2012 documents, in addition to the new map routes that have been filed with the PSC for review.

Executive Session
