APPROVAL TO GRANT VARIANCE OF VILLAGE CODE CHAPTER 66-23 – SCENIUC FOR 11 MONROE STREET DECK

WHEREAS, Tim and Lisa Smythe erected a 10x12 platform style deck on their property approximately 20 feet from the Salmon River's edge, in breech of the Village of Malone Scenic Preservation Law located in the Village Code, Chapter 66, Article IX – Scenic Preservation Districts, §66-23 – Permitted Uses; and

WHEREAS, Village Code Officer, Brian Lamondie, contacted Kevin Riggs with the NYS DEC who stated that the State of New York had no problem with the location of the deck in proximity to the Salmon River; and

WHEREAS, this case was then referred to the Village Planning Board by the Village Code Officer, and was reviewed by the Planning Board at a Public Hearing on March, 31, 2021, at

which time the Planning Board made recommendation to the Village Board that the Smyths be required to move the deck to the 75 foot limit or be granted a variance of the Scenic Preservation Law; and

WHEREAS, Village Code, Chapter 66-23 states, "Within this Scenic Preservation District, which includes that area within 200 feet of the shoreline at normal water level of those streams and waterways as delineated on the map, all development will be in accord with the planned development process as set forth in the following Article. No permanent building or structure shall be located within 75 feet of the shoreline at normal water level except by approval of the Village Board under Article X";

NOW THEREFORE BE IT RESOLVED, the Village Board of Trustees does hereby grant Tim and Lisa Smythe, of 11 Monroe Street, a variance to Chapter 66, Article IX – Scenic Preservation Districts, for the 10x12 platform style deck.
