At a meeting of the Village Board of Trustees of the Village of Malone ("Village Board"), held at the Village of Malone Offices on the 29th day of December, 2021, at 9:00 AM, Village Mayor, Andrea M. Dumas called the meeting to order, and Trustee Bonner, seconded by Trustee McKee, moved the following resolution, to enact the following local law, to be known as Local Law No. 12 of 2021, entitled "A Local Law Adopted Pursuant To Cannabis Law § 131 Opting Out Of Licensing And Establishing Retail Cannabis Dispensaries And On-Site Cannabis Consumption Establishments Within The Village Of Malone" as follows:

WHEREAS, a properly noticed public hearing was held before the Village Board during the meeting on December 29, 2021, on Local Law No. 12 of 2021; and

WHEREAS, the enactment of this Local Law is a Type II Action pursuant to the New York State Environmental Quality Review Act as it involves routine agency administration and management and therefore is exempt from environmental review;

**NOW THEREFORE, BE IT ENACTED** by the Board of Trustees of the Village of Malone as follows:

#### **Section 1. Legislative Intent**

It is the intent of this local law to opt the Village of Malone out of hosting retail cannabis dispensaries and/or on-site cannabis consumption establishments within its boundaries.

### Section 2. Authority

This local law is adopted pursuant to Cannabis Law § 131, which expressly authorizes the Village Board to adopt a local law requesting the Cannabis Control Board to prohibit the establishment of cannabis retail dispensary licenses and/or on-site consumption licenses within the jurisdiction of the Village, subject to a permissive referendum pursuant to Municipal Home Rule Law § 24.

# Section 3. Local Cannabis Retail Dispensary and On-Site Consumption Opt-Out

The Village Board hereby opts-out of licensing and establishing cannabis retail dispensaries and cannabis on-site consumption establishments within its boundaries.

#### Section 4. State Environmental Quality Review Act (SEQRA)

The Village Board has considered the provisions of Article 8 of the Environmental Conservation Law ("SEQRA") and the regulations adopted thereunder at 6 NYCRR Part 617 and finds this Local Law to be a Type II Action as defined therein. Therefore, no further review is required under SEQRA.

#### Section 5. Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

#### Section 6. Effective Date

This local law shall take effect immediately upon filing with the Secretary of State, provided that such filing occurs no sooner than 45 days after the adoption of this local law by the Village Board. Pursuant to Cannabis Law § 131, this local law is subject to a permissive referendum and may not be filed with the Secretary of State until the applicable time period has elapsed to file a petition or a referendum has been conducted approving this local law.

- B. A dog shall not be a "dangerous dog" within the meaning of this section if the owner

shall prove that any threat, injury, or damage caused by such dog was sustained by a person who, at the time, was committing a willful trespass or other tort upon the premises occupied by the owner of the dog, or was tormenting, abusing or assaulting the dog, its owner and/or household members, or has in the past been observed or reported to have tormented, abused or assaulted the dog, or was committing or attempting to commit a crime. Nor shall a dog be a "dangerous dog" if the dog was responding solely to pain or injury or was protecting itself while on its owner's property.
