## > Rural Development Grant Applications

There are possible grant opportunities for the construction of Well #3 and Sewer Plant needs for the processing of Leachate.

- 1. EFC Which includes a 25% in-kind services match and there is a four month wait time to hear if back on the application if being awarded the grant or not. This process would leave time for the accumulation of fines for failure to meet the disinfectant regulations.
- 2. RD Which includes a 25% monetary match and there is an immediate notification of approval or denial. The match is required upfront but there is less risk of fines for violations.

The grant application submitted by Barton and Loguidice for the UV lights was not awarded.

Need extension for UV Disinfectant - Also a possible RD Grant for treatment of substances coming into plant before the need for disinfection becomes necessary. Must remove organics (folic acid) to prevent the continuation of damage to the UV tubes. It is a mechanically filterable substance.

Replacement unit and construction costs could run upwards of \$750,000.
