Village Updates

- Two properties on Route 30 needing water service are working to tap onto the private water line that extends from where the Village water line stops. If they can work out an agreement with this Private landowner, they will then be added to the quarterly Water and Sewer Billing. Town Supervisor Stewart is beginning the process of looking into the establishment of a Northern and Southern Water District.
- ➤ DANC drafting an agreement to provide the Village of Malone with coverage under their Class D water license. DANC would like to see cross training completed on those employees working with Water and Wastewater, effectively assisting them in obtaining their Class D License.
- Discussion on the upcoming retirement of Lloyd Marlow and possible candidates to assume his position as Working Foreman.
- Discussion of Payment Terms for new Water Meters being installed. Customers will have 60 days from the date of installation to pay for the new meters and fee to install.
- > Trustee Langdon noted that he was hearing all good reports about the new Code Officer. Asked if the Village could provide him with s few shirts and a jacket.
- > Trustee Langdon asked if the crater on Academy St was being addressed. The Mayor confirmed that it was.
- > Trustee Langdon requested that all Village Employee travel and training be suspended due to finances. The Mayor confirmed that this was already in place.
- > Trustee Langdon update the Board concerning his research about the implementation of High-Speed Internet at the Water Tower; Spectrum is currently working on a proposal for the Village.
- > Trustee Langdon mentioned that it has been three years since the Village was going to pour cement pads under current benches. Trustee Bonner noted that the Village is unable to pour until written approval from the landowner is received by the Village.
- > Trustee Langdon asked why some streets had only been swept one time this year by the DPW. Mayor Dumas noted that there were several Village residents who put debris to the curb after the official pick up date, thus preventing a second sweeping from happening.

- Trustee Langdon noted that the DPW generator is still running and this is costing the Village on fuel. Mayor Dumas noted that Northline Electric would be coming to the site that evening to assess the issue and provide the Village with a concise plan to move the entrance to the other building.
- > Trustee Langdon seeking quote from Nason to take care of the air conditioner and boiler in the Village Office building.
- Mayor Dumas noted that DANC had completed the Health and Safety Manual and has submitted it to the Village for review.
- ➤ Elizabeth Weisman has complained that garbage is once again piling up on Brown Street. Mayor Dumas will send Code Officer Lamondie to assess the situation.

Rec Park Land Purchase

Trustee's Bonner and Boyea noted that the Join Rec Commission had passed a resolution to purchase the available 22 acres of property as a means of preserving the rights to the walking trails currently located on that property.
