**VILLAGE UPDATES**

Grant opportunity from Assemblyman Jones to the American Legion/Am Vets in the amount of \$250,000. The funds could possibly cover work on Memorial Park to update the current fountain,

slate walkways, add more shrubbery, update electrical and water system, including moving the on/off location, update lights and improve the current monuments.

DPW working to resolve some safety issues in the Main Street parking lot near Lashomb's Insurance Agency. They have removed sidewalk blocks that were broken, are assessing the staircase that was put in roughly 25 years ago which is beginning to pull away from the wall causing a trip hazard. The back wall is also beginning to shift, and the bottom sidewalk is sinking in. Those sidewalk squares are being pulled up now so a drainage pipe can be added to resolve the erosion issues that are the cause of the current issues. The parking lot has also begun to settle so the curbs need to be replaced and the lot needs to be leveled. Due to the salt use by the NYTS DOT during the winters, the sign is rotted through so that has also come down to be repaired.

There are eleven crosswalks left to paint, roughly 115 water meters left to install, and some abandoned properties to be mowed. The Mayor would like to see some of these abandoned properties moved to auction.

Upon the motion of Trustee Bonner with a second by Trustee McKee and unanimously carried to go into Executive Session on a Contractual Issue with MEDCO.


Upon the motion of Trustee Langdon with a second by Trustee McKee and unanimously carried to come out of Executive Session.
