Trustee McKee: Twelve outstanding MEDCO loans total \$526,706. No one has made application to the court system for relief of payment. MEDCO turned all the assets over to the Village of Malone in July 2012. We will send bills to each one. Trustee McKee also mentioned that we have some properties that we would like to sell and he will do some research and give the Board a report on this.

NEW BUSINESS:

E-Code 360 – Presentation by Jeannie and Todd from E Code. We have been with General Code since 1965 and have had over 90 supplementations. They explained to the Board what it will entail to convert over to E-Code. General Code would be doing away with the 6 x 9 books, just having one 8 ½ x 11 on hand, and we would be able to have everything on the internet. More information will be forthcoming as Todd

and Jeannie prepare an estimate for the Board as far as the pricing structure.

Matt Tessier – Star of the North – Matt is here tonight to ask for the Board support as well as the Police Department's support as he prepares to organize a 5K Run, a 10K Run, a half marathon and a full marathon. The dates would be 8/31/2019 and 9/5/2020. They would need help from about 7:30 AM to 12:30 PM.

SWAP – Authorization for Mayor to Sign – A letter will be sent to D. This is similar to the CHIPS funding and is a new program but for under the ground. The Board is certainly in support of this and authorizes the Mayor to sign.

Village of Malone vs. Malone Housing Authority – Demarest Mediation Services has rendered its decision on the arbitration between VOM and MHA. This is in reference to the authority deducting from its annual PILOT to the Village the costs it incurs for fire protection services from the Town of Malone. The answer is no they cannot. We may be able to recoup some monies down the road. The Board is being asked to approve the \$500 for the services rendered. This was in the bills tonight for approval.
