Jason Smart had two questions – One – how is it that a man can walk up onto his porch at 3:45 am and this is not considered trespassing. He has video footage of this man.

Mayor Dumas stated she would get Mr. Smart a meeting with the Chief.

Question Two - Mr. Smart had a water leak a few months earlier that caused a flood in his home and he called in a water turn-off. Once repairs were made, Mr. Smart had to pay the Water-off and Water-on fee of \$30 for the water to be turned back on. Why when this was an emergency?

Mayor Dumas cited the Village Local Law that mandates all off and on bear a charge of \$15.00 each, for a total of \$30 for both.

Trustee Langdon left the meeting for a coroner's call at 6:56 PM.

Tom Shultz asked if there could be a document loaded to the Village Website that shows all new building permits.

The Village will investigate producing something that shows all permits without disclosing personal information about the applicants.
