longer plague the airport, which is beneficial to the twin prop engine planes. They are available to speak with anyone from the Village or Town.

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF ENGINEERING PLANNING GRANT APPLICATION NUMBER 131218 FOR WASTEWATER TREATMENT PLANT IMPROVEMENTS TO COMPLETE THE DECOMMISSION OF OUTFALL 002 PRELIMINARY ENGINEERING REPORT

WHEREAS, the Village of Malone has requested from New York State Department of Environmental Conservation (DEC) a permit modification to the Village's State Pollutant Discharge Elimination System (SPDES) Permit to decommission Outfall 002 at the Village wastewater treatment plant (WWTP); and

WHEREAS, the New York State DEC and Environmental Facilities Corporation (EFC) Wastewater Infrastructure Engineering Planning Grant (i.e. EPG) program is an eligible funding source for a study to complete this project; and

WHEREAS, the Village of Malone submitted a 2023 New York State Consolidated Funding Application (CFA) to develop a Preliminary Engineering Report (PER) to evaluate alternatives and recommended improvements to Decommission Outfall 002 and all its related equipment; and

WHEREAS, the Village has been selected to receive up to \$50,000 from the EPG to fund the study of Village's wastewater treatment plant disinfection system.

THEREFORE, BE IT RESOLVED, that the Village authorizes and appropriates a minimum 20% local match as required by the Engineering Planning Grant Program for the Village's Wastewater Treatment Plant PER Development for Decommissioning Outfall 002. Under the EPG program, this local match must be at least \$10,000. The source of the local match, and any amount in excess of the required match, shall be provided by the Village with either in kind services or Village sewer funds. The maximum local match shall not exceed \$10,000 based upon a total estimated maximum project cost of \$50,000. The Mayor may increase this local match through the use of in kind services without prior approval from the Village.

BE IT FURTHER RESOLVED, that the Mayor or his assigned designee, is hereby authorized to act as the projects "Authorized Representative", and to enter into any necessary contracts to administer said grants.

WHEREAS, if a full waiver is not approved, then the Authority will not be able to complete the work as proposed.
